### **CERTIFICATION**

I, Laura Kopsa, Tama County Auditor and Commissioner of Elections, do hereby certify that the above ballot is a true and correct copy of one of the official ballots to be voted upon in the Special Election on Tuesday, March 7, 2023. The following propositions will appear on the ballots in the specific jurisdictions:

### Public Measure TY

Shall the Board of Directors of the North Tama County Community School District in the County of Tama, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$14,250,000 to be used together with sales tax bond proceeds to provide funds to build, furnish, and equip a new high school addition, including related remodeling and improvements; to remodel, repair, furnish, and equip the existing educational facilities; and to improve the site?

# Public Measure TZ

Shall the Board of Directors of the North Tama County Community School District in the County of Tama, State of Iowa, be authorized to levy annually a tax exceeding Two Dollars and Seventy Cents (\$2.70) per Thousand Dollars (\$1,000), but not exceeding Four Dollars and Five Cents (\$4.05) per Thousand Dollars (\$1,000) of the assessed value of the taxable property within said school corporation to pay the principal of and interest on bonded indebtedness of said school corporation, it being understood that the approval of this proposition shall not limit the source of payment of the bonds and interest, but shall only operate to restrict the amount of bonds which may be issued?

## Public Measure BK

Shall the Hawkeye Community College (Merged Area VII) in the Counties of Benton, Black Hawk, Bremer, Buchanan, Butler, Chickasaw, Fayette, Floyd, Grundy and Tama, State of Iowa, be authorized to contract indebtedness and issue its School Bonds in an amount not to exceed \$35,000,000 to provide funds to defray the costs of any one or more of the following purposes: to improve its Main Campus and construct, remodel, expand, erect, equip and furnish buildings thereon and construct, acquire, improve, expand, remodel, furnish, and equip new or existing facilities within Merged Area VII?
